The SPCID Chairman Jacques Weber opened and welcomed all to the meeting.

Jacques Weber asked Wayne Ripepi if there was a quorum present, Wayne confirmed that there was a quorum present so meeting could go ahead.

NOTING OF AUDITED FINANCIAL STATEMENTS 2023-24.

Mr. Jacques Weber presented the AFS and called for the approval of the 2023 -24 Financials. Proposed by Mr. R. da Luz and seconded Mr. P. Berman. There were no questions raised. The full set of the AFS is available on the website.

It was explained that in terms of the Financial Agreement there must be a minimum of 2 months surplus available to which the SPCID adheres to.

APPROVAL OF IMPLEMENTATION PLAN 2025/26.

This was approved by Mr. R. da Luz and seconded Mr. H. Venter and ratified by members present.

CONFIRMATION OF ANNUAL REPORT 2023/24

This was approved by Mr. H. Venter and Mr. R. Da Luz. Members at the meeting voted in favour of the motion.

AUDITORS.

Raft was appointed as the Auditors. Approved by Mr. R. Da Luz and Mr. P. Berman. Members at the meeting voted in favour of the motion.

COMPANY SECRETARY.

Nazeer Rawoot has been appointed as Company Secretary and he accepted the position, approved by Mr. H. Venter and Mrs. Elizabeth Botha, members at the meeting voted in favour of the motion.

ELECTION OF OFFICIALS.

Jacques Weber indicated that the SPCID Board has five board members. Two must resign as per the MOI requirements. Mr. H. Venter and Mr. R. Da Luz resigned; both were re- elected to the Board. The meeting unanimously approved this proposal.

Cllr. JOWELL.

I do not have much to say, as you have covered everything, just to say that partnerships are very important and the Sea Point CID acts as a top up service to the City of Cape Town, Law Enforcement, SAPS and Metro Police.

Col. ENGELBRECHT.

The acting Station Commander at Sea Point Police Station thanked the Board for standing for another year and he complimented the Sea Point CID for ensuring the safety of people in the area. He also thanked Law Enforcement for their work in keeping the Promenade safe. He explained that there is still a bit of concern in the Granger Bay around the Radison Hotel such as theft out of motor vehicles. There are new faces in the area causing problems, so for the upcoming Festive Season partnerships between the various Law Enforcement Agencies and security companies in the area is of utmost importance.

Regional Insp. W. SCOTT.

Partnering with various Law Enforcement Agencies, Security Companies and the Sea Point CID is very important to us, reuniting homeless people with their families is very important to us. The concern is that the Castle area is being cleaned so a lot of those homeless people will be moving into The Green Point, Sea Point area, with huge events also planned for the rest of the year we will have to be very proactive to prevent these people from settling in these area.

Heather Tager the COO for the Sea Point CID thanked all role players for their assistance, your comments and you cannot do things alone, so partnerships is very important.
